At 2:08 pm, Board Vice President May called the meeting to order and acknowledged the presence of a quorum.

A. REGULAR SESSION - CALL TO ORDER

B. REGULAR AGENDA - NEW BUSINESS

- 1. City Council Liaison update regarding City events, meetings, etc. DeShaundra Lockhart Jones. Ms. DeShaundra Lockhart Jones was not present to provide an update.
- 2. DeSoto Chamber of Commerce Update Laura Terhune, President
 - An After Hours Business Expo was held on Thursday, August 10, 2017 at the TownePlace Suites a) by Marriott.

- b) The Member Lunch & Learn Benefits of Chiropractic Health was held on Tuesday, August 15, 2017 at the TownePlace Suites by Marriott.
- c) The Annual Member Appreciation Luncheon will be held on Thursday, September 14, 2017 at the Methodist Charlton Auditorium.
- d) The DeSoto ISD New Employee Business Expo/Reception was held on Thursday, August 4, 2017, and 21 vendors participated.
- e) The Taste of DeSoto will be held on Thursday, September 28, 2017 at the Civic Center, and 41 vendors are registered.
- f) The Fourth Friday Concert & Beneath the Stars Poetry Slam will continue in September.
- g) There was a Candidate Forum for Place 7 held on Saturday, August 12, 2017, and was cohosted by Concerned DeSoto Citizens.
- h) The Chamber will not renew the contract with *Travel Host*, but will continue to advertise in *Texas Highways*, and have signed a contract for 2017-18 with the *Texas Sports Facility Guide*. The DeSoto Visitors Guide & Reunion Planning Guide is underway, and they have assembled and distributed 175 reunion/group goody bags in the last month. The 2018 Community Guide contract is pending and they are anticipating a spring delivery. The current advertising campaign includes general tourism and the ReunionCapitalofTexas.com. The Tourism Marketing Plan is in its third draft and the spending budget is being finalized. The Sports Tourism Marketing Strategy is currently in the planning stages with the DEDC, the City of DeSoto, DeSoto ISD, and the private sector.
- i) Current fundraising efforts include the Saxy Sunday Brunch will be held on Sunday, August 27, 2017 from 1 to 4 pm at The Chocolate Mint, the Annual Gala which will be held on Saturday, November 4, 2017, and the graphic design for the Brick Sales marketing campaign is being finalized.
- j) Current Revolving Loan Fund Applications include Couch Potato who is finalizing their business plan, and will be presenting to the Revolving Loan Fund Committee on August 29, 2017. There will be a Business Fundamentals Workshop on September 19, 2017 at the TownePlace Suites by Marriott.
- k) The CEO's of the Chamber and EDC selected colors and finishes for the new CVB building which will house the DCOC and the DEDC. The Chamber's Lease agreement at the Grow DeSoto Incubator is pending as the Chamber is making additional changes to the space.
- I) The Chamber's Membership Coordinator spent a lot of time prospecting new businesses for new membership and member visits. The current Business Retention contract between the Chamber of Commerce and the DeSoto EDC is up for renewal at the end of Fiscal Year 2016-17, and is self-renewing unless either party opts out of the current terms which states the Chamber of Commerce should make 10 site visits per month.

3. Treasurer Report – Director Stephanie Bowers

Ms. Bowers mentioned that Vice President Belinda May made a budget presentation for Fiscal Year 2017-18 on July 20, 2017 to City Council, and on July 21, 2017 the Bank of DeSoto, Plains Capital Bank, and Comerica Bank Certificates of Deposit were updated to remove the previous President and staff that are no longer working for the DeSoto EDC. On August 15, 2017 there was an approval made for a payment by the City of DeSoto of the sales tax and revenue fund bond, an interest debt service payment in the amount of \$31,550 on behalf of the DeSoto EDC. Beginning August 21, 2017 Whitley Penn started their audit process of DEDC financial statements, activities, and major funds. The process will conclude March 2018, at which time they will issue an audit report.
