

DESOTO ECONOMIC DEVELOPMENT CORPORATION BOARD MEETING MINUTES FEBRUARY 11, 2019

The DeSoto Economic Development Corporation Board met at **9:00 a.m. on Monday, February 11, 2019** in the Council Conference Room located in City Hall at the DeSoto Town Center, 211 East Pleasant Run Road, DeSoto Texas 75115.

At 9:06 a.m., Board President Perry Holloway called the meeting to order and acknowledged the presence of a quorum.

A. <u>REGULAR SESSION – CALL TO ORDER</u>

1. Invocation was given by Board Vice President Curtis Krohn.

B. REGULAR AGENDA – NEW BUSINESS

 Consideration and action to approve allowing the CEO Joe Newman to change the signature on all financial accounts (Wells Fargo checking account and three Certificates of Deposit accounts) to the Board President Perry Holloway, Board Vice President Curtis Krohn, and Board Treasurer Michelle Jordan; and to remove former Board President Belinda May, and former Board Treasurer Bobby Waddle from all of the same financial accounts.

Motion by Board Director Bobby Waddle to approve allowing the CEO Joe Newman to change the signature on all financial accounts (Wells Fargo checking account and three Certificates of Deposit accounts) to the Board President Perry Holloway, Board Vice President Curtis Krohn, and Board Treasurer Michelle Jordan; and to remove former Board President Belinda May, and former Board Treasurer Bobby Waddle from all of the same financial accounts. Seconded by Board Director Bobby Waddle. Approved by Board members Perry Holloway, Curtis Krohn, Michelle Jordan, Bobby Waddle, and Delva King.

- 2. Consideration and action to approve the advertising in the Dallas Regional Chamber's Economic Development Guide magazine for \$20,000.
 - **a.** Joe Newman, Chief Executive Officer, explained the benefits having an advertisement in the Dallas Regional Chamber's Economic Development Guide. He elaborated on the how this advertisement and those in similar publications may have sparked interest in the Grow DeSoto Market Place incubator and other local businesses.
 - **b.** Board President Perry Holloway expressed concerns that \$20,000 is a substantial amount of money to spend on a print advertisement without any way to tract which magazines are generating the most attention and provide the most economic growth.
 - c. The Honorable Rachel Proctor, Mayor Pro-Tempore, mentioned to the Board of Directors that the real estate billboards have a tracking number on them to allow business owners to collect this type of data. With this in mind, she posed the question of how can we track our print advertisements to assure that we know which magazines are being viewed to account for the \$20,000 we spent.
 - **d.** Board Treasurer Michelle Jordan pointed out that magazines typically have websites which include data collection on ads in their magazine.
 - **e.** Board President Perry Holloway agreed and concluded that there needs to be away to better track which magazines provide the most exposure to justify \$20,000 worth of advertisement purchasing.
 - **f.** Board Director Bobby Waddle said advertisements in the past were done differently, and he realizes and understand that now there are new ways to advertise our businesses in DeSoto. However he feels that if there is a cheaper alternative to what we have been doing, the board should find the most cost effective solution.
 - g. Joe Newman, CEO, assured the Board of Directors that he will implement and utilize advertisement tracking from now on to collect data on which print advertisements provide the most exposure of DeSoto businesses. Joe Newman said he will obtain a quote for a one page advertisement to present to the Board of Directors at a later date.

Board Treasurer Michelle Jordan felt that the Board of Directors were most capable of facilitating their Board Retreat. Board President Perry Holloway informed the Board of Directors that the Heliport is where

the Board Retreat was held in the past, and he announce that an email will be sent to everyone to confirm the location, date and time of the this event. All of the Board Directors were in agreement. **No action.**

Board President Perry Holloway called a 10 minute break at 9:16 a.m.; whereas, afterwards he called the Board Directors into Executive Session at 9:26 a.m.

- Start the budgeting process with suggested changes
- Ideas on the Grow DeSoto Market Place's marketing and costs
- Website update and timeline
- Consider moving the DEDC office to the current DeSoto Chamber of Commerce building
