A. <u>SPECIAL SESSION – CALL TO ORDER</u>

1. Invocation was given by Andre` Byrd, Sr., Council member, City Council Liaison.

B. SPECIAL AGENDA - NEW BUSINESS

Discussion and possible action to change and update signatures on various DeSoto Economic Development Corporation (DEDC) financial and banking accounts and related instruments and documents including, but not limited to, checking and Certificates of Deposit. Board Vice President Curtis Krohn announced that Board President Perry Holloway resigned.
