

# DESOTO ECONOMIC DEVELOPMENT CORPORATION SPECIAL CALLED MEETING MINUTES BOARD RETREAT MARCH 22, 2019

At 9:18 a.m., Board President Perry Holloway called the meeting to order and acknowledged the presence of a quorum.

#### A. <u>REGULAR SESSION – CALL TO ORDER</u>

1. Invocation was given by Board Vice President Curtis Krohn.

#### C. REGULAR AGENDA - NEW BUSINESS

1. Consideration and action to approve advertising in the Best Southwest publication with the DeSoto Independent School District, the City of DeSoto, and the DeSoto Chamber of Commerce. Presentation by Matt McWorter, Executive Integrated Media Manager, Livability Media.

- a. The Board of Directors discussed the advertisement's design, the other contributing partners' contribution, modes of distribution, and the DeSoto livability website during the presentation with Matt McWorther Executive Integrated Media Manager of Livability Media.
- **b.** After the Board of Directors critiqued last year's advertisement design layout, they agreed to have Joe Newman, CEO, be the main point of contact to work closely with Mr. McWorther to improve this year's design layout.
- **c.** Board Director Dr. Delva King said she would like to be involved in the editing of the advertisement's design.

Motion by Board Vice President Curtis Krohn to approve advertising in the Best Southwest publication with the DeSoto Independent School District, the City of DeSoto, and the DeSoto Chamber of Commerce in the amount of \$5311.25. Seconded by Board Director Dr. Delva King. Motion approved by Board members Perry Holloway, Curtis Krohn, Michelle Jordan, Bobby Waddle and Dr. Delva King.

## Board President Perry Holloway moved to item 6.

- 2. Distribute and discuss the "Board Members' Responsibilities" material.
  - **a.** Joe Newman, CEO, presented a description of what board member responsibilities are to the Board of Directors for them to discuss.

## Board President Perry Holloway moved to item 5.

- **3.** Roundtable discussion by each Board Director and what strengths they bring to the Board of Directors.
  - **a.** Each Board member introduced themselves to the group and discussed their experience, expertise, and strengths that each one brings to the group.

### Board President Perry called a break at 11:55 a.m. for lunch and reconvened at 12:12 p.m.

- **4.** Open Meetings/Open Records training presented by attorney Pete Smith, Attorney, Nichols, Jackson, Hager, and Smith, LLP.
  - a. Mr. Smith provided a training session for the Board of Directors on the Open meeting/Open records requirements and answered all related questions from the Board of Directors.
- **5.** Solicitation, consideration, and action to approve ideas for marketing the Grow DeSoto Market Place (Incubator).
  - Consideration and action to approve amending the Marketing Budget presented by Ms.
     Toomey, Executive Director, The Industry HUB.
    - i. Terry Toomey, Executive Director, The Industry HUB, said she is in a testing phase, but her reports show that the business owners' sales are driven by events.
    - **ii.** Ms. Toomey said they will have different events on different days to increase the traffic and the impressions to the Grow DeSoto Market Place website and Facebook page. She presented the statistics from each day of the website and showed what is driving the statistics.

- iii. Ms. Toomey discussed the statistical increase in sales based on the events and host engagements. She attributed much of the increase to the inclusion of Brandon Moore, Social Media Consultant, who is managing the event marketing on the Grow DeSoto Market Place website and the other social media platforms. She also attributes the increase to the individual videos that he has produced.
- iv. Ms. Toomey explained that they need Dailia Thomas, Public Relations and Media Consultant, to create public relations opportunities such as the influencer "Sip and Shop". She said the many of the residents of DeSoto are still unaware of its existence even after the past media efforts.

Motion by Board Treasurer Michelle Jordan to approve the increase to the Grow DeSoto Market Place budget to be used for marketing the Grow DeSoto Market Place (Incubator) as presented by Terry Toomey, Executive Director, The Industry HUB, for seven months at \$4,379.90 per month, and to authorize Joe Newman, CEO, to take the necessary action to accomplish it. Seconded by Board Director Dr. Delva King. Approved by Board members Perry Holloway, Curtis Krohn, Michelle Jordan, Delva King and Bobby Waddle.

Board President Perry Holloway called a 5 minute break at 11:00 a.m.; whereas afterwards, he reconvened at 11:12 am and moved to item 3.

- **6.** The New DEDC website update and proposed timeline presented by Vanessa Barrios, Research and Business Development Manager.
  - a. Ms. Barrios introduced Sam Toerper, Owner, Freehand, to present on how the new website will look and function. He discussed how the new website will be both f friendly and desktop friendly. He said the new website's structure will include doorways that will easily show viewers first the items that are most important to them.
  - **b.** Ms. Barrios discussed how the new website incorporates the rebranding that she has been developing and the possibility of adopting a new tagline that is not the same as but complements the City of DeSoto's tagline.
  - **c.** Ms. Barrios explained that the new website will have additional features such as interactive maps and video testimonials.
  - **d.** Ms. Barrios said that the beta testing for the website will utilize information she acquired directly from realtors in the area, so that she can incorporate what would interest them the most into the website.
  - **e.** Ms. Barrios said that the new website will be completed by June 1, 2019.

### Board President Perry Holloway moved to item number 2.

- 7. Consideration and action to approve moving the DEDC offices to the current DeSoto Chamber of Commerce building located at 304 N. Hampton Road, DeSoto, Texas or the DeSoto Heliport building located at 150 E. Danieldale Road, DeSoto, Texas.
  - a. Dr. Richardson, City Manager, discussed the benefits to the City of DeSoto's offices by allowing it to better prepare for expansion and existing space issues. Also, he mentioned that by moving to the Chamber of Commerce building the DEDC offices would have a better working proximity to the Chamber of Commerce offices. This would allow for ease of communication between the two on many of their joint projects.

**b.** Dr. Richardson informed the Board of Directors that there will be renovations to the building to make it more usable and American Disability Act (ADA) compliant. He said that moving would not be immediate, and that it would need to be approved by the City Council before any action could be taken.

Motion by Board Vice President Board Curtis Krohn to approve the DEDC procurement policies and procedures update to be the same as the City of DeSoto procurement policies and procedures. Seconded by Board Treasurer Michelle Jordan. Approved by Board members Bobby Waddle, Dr. Delva King, Perry Holloway, Michelle Jordan, and Curtis Krohn.

Board President Perry called a break at 1:17 a.m. and reconvened at 1:41 p.m.

- 9. Consideration and approval of the 2019 DEDC strategic Plan updates.
  - **a.** Joe Newman, CEO, started to explain some of the Strategic Plan 2019 changes. Then he said he did not want them to rush through it, but he wanted them to have enough time to consider everything in it.
  - **b.** Mr. Newman explained the sales tax changes in the Strategic Plan 2019 (Draft) to the Board of Directors, and he answered any additional questions they had.
