Motion by Curt Krohn to approve Consent Agenda. Second by Bobby Waddle. Motion approved by L. Williams, B. May, and S. Bowers (motion approved 5-0)

C. <u>REGULAR AGENDA – NEW BUSINESS</u>

- 1. City Liaison Update Council member C. McCowan update on City Council events, meetings etc.
- a) DEDC Vice President Belinda May and CEO Jeremiah Quarles, along with Dr. Sedighi and Dr. Bailey with the Global Prime, provided a detailed briefing and fielded questions from Council regarding the proposed project. Vice President May recommended Council approve the project, as it is in line with the Hampton Road Corridor Redevelopment Project. Following the presentation, Dr. Tarron Richardson, City Manager advised Council that he would be prepared to present the deal points and proposal for the land grant at the November 17 City Council Meeting.
- b) During the City Council's Regular Session on November 3, Council approved Zoning Case Z1313-15 regarding property located south of Danieldale Road and between Old Hickory and Jo Drive. E. ACTION RESULTING FROM EXECUTIVE SESSION

Second by Bobby Waddle: To authorize CEO to negotiate and execute on behalf of the DEDC an incentive agreement with RPG Capital Management LLC to provide funding for infrastructure for commercial building project not to exceed \$100,000 to be paid in two equal installments to be paid upon completion of construction and second installment to be paid on first anniversary date of completion of construction, provided the project is completed within 18 months.
