# C. REGULAR AGENDA - NEW BUSINESS

1. City Council Liaison update regarding City events, meetings, etc. – D. Lockhart Jones

On February 17<sup>th</sup> & 18<sup>th</sup> the City Council participated in the Winter Retreat at the Manderley Event Center. Several items were discussed: The Fire Department has received smoke detectors through a new donation program and is also installing in some resident homes, doing this as a proactive effort.

Council also reviewed the parking and sign ordinance to make trash pick-up easier on street and alley ways. City is also in process of repairing some streets and sidewalks around the City. The DeSoto Job Fair was also discussed, and City will be hosting this event in partnership with DeSoto EDC, DeSoto Chamber and Texas Workforce Commission. They also addressed the transportation issues with Star Transport, this is a program to pick up and transport seniors with medical concerns.

The City of DeSoto will be having the Employee Health Fair on March 15<sup>th</sup> for all employees. City Council is hosting the Annual Boards & Commissions Banquet on Thursday, March 23, 2017 for all members in appreciation for their service. The City Council Places 2 and 4 are uncontested and therefore no need for an election. The annual recycle event is scheduled for April for DeSoto residents, and recommendation was made to have two times a year.

# 2. DeSoto Chamber of Commerce Update - Laura Terhune, President

The Annual "State of the City" Luncheon had 165 attendees and has been the largest luncheon the Chamber President has attended. Second Quarter Luncheon "Economic Development Update" is scheduled for April 13<sup>th</sup>, featuring Murphy Cheatham on EDC projects. The Annual "First Responders Appreciation Luncheon is planned for Thursday, May 18<sup>th</sup> at Methodist Charlton Medical and they would like to expand invitation to other cities in the Southwest area. DeSoto Living! Festival scheduled for Saturday, April 1<sup>st</sup> at DeSoto East Middle School and has 88 vendors registered in 103 booths.

Chamber had Business Round Table Discussion with Senator Ted Cruz on Friday, February 24<sup>th</sup> at DBU with local business owners. Discussion on issues that Washington lawmakers could have some influence on regulations for import export issues and health care. Ms. Terhune participated at the "A Heart 2 Serve" and was a presenter at the event on Saturday, February 25<sup>th</sup>, her topic was Shop Local.

# 3. Update Board on following Projects

- b. Brookhollow Shopping Center DeSoto Business Incubator Project

Mr. Cheatham/CEO mentioned that the Global Prime project was presented to Planning and Zoning Commission for their review and future development plans. They will also be back to present to City Council. He is also introducing the Brookhollow Shopping Center to Planning and Zoning. It is an incubator project, planned for multiple tenants. He is partnering with BCL of Texas to help small business owners with the aspects of ownership and loan assistance. Tenant improvements have already begun.

Mr. Cheatham, DeSoto CEO briefed Board on the latest developments with regards to the 2016 - 2017 DEDC updated budget, gave a summary and overview of the working budget. He is working on the reorganization of the corporation and plans to fill two

positions: Business Development Manager and Marketing Specialist. He is also in the process of developing the DEDC Personnel Policy.

He plans to obtain a full commercial Real Estate Market Study for Retail, Office and Light Industrial for DeSoto and the studies to be updated on an annual basis.

Mr. Cheatham will be participating at the Chamber Second Quarter Luncheon, speaking on "Economic Development Update".
