At 9:06 a.m., Board President Williams called the meeting to order and acknowledged the presence of a quorum.

## A. REGULAR SESSION – CALL TO ORDER

- 1. City Liaison Update Council member C. McCowan's update on City Council events, meetings etc.
  - a. City Council and DeSoto ISD School Board conducted a joint meeting the previous week in regards to future joint projects for the City of DeSoto. Future appointed committee will likely be formed to discuss potential projects. Potential projects mentioned: Aquatics Center and a jointly sponsored Arts Center.

  - a. Terhune noted upcoming Chamber events: Quarterly Luncheon, Business Networker, and a Search Engine Optimization Lunch & Learn event for small businesses. New Date for Taste of DeSoto set for May 7.

  - c. Metroplex BMX will be utilizing the Passkey Program for funding based on the number of hotel rooms booked for a major BMX event in the fall. Super Nationals

- 3. Discussion and possible action on street light improvements along Polk Street near Daineldale Road. Tom Johnson, Planning Department
  - a. Johnson reported on the gap in financing in the contract between the DEDC and KTR Capital for street lights along the new Polk Street improvements from Centre Park Boulevard to Danieldale Road. The Planning Department is asking the DEDC to cover the cost of 20 center median signature light posts not to exceed \$27,000 from Oncor Electric.

Motion by B. May to authorize DEDC CEO to negotiate and execute a contract up to \$27,000 for the purchase of street light improvements along Polk Street between Centre Park Boulevard and Danieldale Road with Oncor Electric. Second by B. Waddle.

Motion approved by L. Williams, B. May, P. Holloway, and B. Waddle (4-0) B. Dendy absent.

## E. ACTION RESULTING FROM EXECUTIVE SESSION

Board President Williams adjourned the Executive Session at **11:17 a.m.** and re-convened the meeting in Open Session. Following the executive session the following motion was made and approved:

May to authorize DEDC CEO to negotiate and execute an incentive agreement on behalf of DEDC with South Dallas LLP to provide an infrastructure grant in the amount of \$250,000 to be paid upon issuance of a certificate of occupancy for a tenant to occupy a building containing approximately 453,000 square feet to be constructed at southeast corner of East Centre Park Boulevard and Chalet Drive. Second by B. Waddle. Motion approved by L. Williams, B. May, P. Holloway, and B. Waddle (4-0) B. Dendy absent.
- 2. Motion by B. May to authorize DEDC CEO to negotiate and execute on behalf of the DEDC an amendment to the agreement with Eagle Hotel Group L.P. to reduce the number of suite rooms in the hotel to not less than 97 suite rooms and extension of the commencement of construction date. Second by P. Holloway. Motion approved by L. Williams, B. May, P. Holloway, and B. Waddle (4-0) B. Dendy absent.

  - i) CEO noted that Fitch affirmed City of DeSoto's GOs and COs at 'AA'; the rating outlook is stable; Project Purple Comfort is still in the negotiating process with three potential sites in the DFW Metroplex, DeSoto's Southfield 35 location is on their short list; Slight uptick in unemployment for DeSoto from 5.25 to 5.5 between March and April 2015; DeSoto resident Matt Jones won the NCAA Men's Basketball

Tournament with Duke University, and Moriah Jefferson won the NCAA Women's Basketball Tournament with the University of Connecticut
