

DESOTO ECONOMIC DEVELOPMENT CORPORATION BOARD MEETING MINUTES

June 17, 2016

The DeSoto Economic Development Corporation Board met at 9:00 a.m. on Friday, June 17, 2016 in the Council Conference Room located in City Hall at the DeSoto Town Center, 211 East Pleasant Run Road, DeSoto Texas 75115.

At 9:04 a.m., Board President Williams called the meeting to order and acknowledged the presence of a quorum.

B. <u>CONSENT AGENDA</u>

a. Approval of the May 27, 2016 Board Meeting Minutes

Motion by Board member May. Second by Board member Waddle to approve Consent Agenda. Motion approved by Board members May, Waddle, Bowers, Williams (Motion approved 4-0, C. Krohn was absent during the vote)

C. REGULAR AGENDA – NEW BUSINESS

- 1. City Liaison Update Councilmember D. Lockhart-Jones update on City Council events, meetings, etc.
 - a. City Council retreat is scheduled for July 15-16, 2016. Location to be determined.
 - b. The financial funding was approved for the Annual Juneteenth Celebration scheduled for Saturday June 18th at Ryan Park.
 - c. City Council is hosting the Employee Appreciation Luncheon and will serve lunch to City employees in appreciation for their time and service.

- 3. Discussion the final DEDC Financial Statements prepared by Whitley Penn for Fiscal Year ending September 30, 2015 Dan Hernandez, CPA
 - a. DEDC is in a very healthy situation. At the close of FY 2015 the DEDC reported an ending fund balance of \$3.4 million which was an increase of \$416,333 from the prior year.
 - Long-term liabilities had a net decrease of \$236,925 due to the DEDC aggressively paying down on the bond commitments and its Heliport commitment to the City.
 - c. Most EDCs operate from negative net position; however the DEDC net position has been in the black (positive) since 2014. In 2015, net position reached \$971,750
 - d. Mr. Hernandez applauded the DEDC Board and Staff on its history of running a fiscally sound organization that produces steady growth. He also added that it was a joy to work with staff during the 'gathering of information' stage.

Motion by Board member May. Second by Board member Krohn: To authorize the CEO to execute an incentive agreement on behalf of the DEDC with SEW Eurodrive in the amount of \$250,000 payable in one year after completion. Motion approved by Board members May, Krohn, Williams, Waddle and Bowers (motion approved 5-0)
