1. Discussion and action to elect a member of the DEDC Board of Directors as Treasurer

Motion by Board member Waddle. Second by Board member Krohn to elect Stephanie Bowers to Treasurer. Motion approved by Board members Waddle, Krohn, Williams, and May (Motion approved 4-0)

- 2. City Liaison Update Councilmember D. Lockhart Jones update on City Council events, meetings, etc.
 - a) The City Budget was approved and property taxes were reduced to \$0.7499. The City of DeSoto received a strong financial rating of AA from Standard & Poor. Councilmember Lockhart-Jones gave an update on Chattey Road improvements and street modifications. Boards and Commissions interviews will be conducted on Tuesday, September 27th. Several positions are open.
 - b) The "Walk to School" event will take place at Northside Elementary. It is a project that allows individuals to walk to school with children and have an opportunity to interact with students.
 - c) "National Night Out" is scheduled for October 4^{th.} DeSoto's Police Department encourages the community to get out and meet their neighbors. Food and safety tips will be offered to all.

 - a) Chamber is getting ready for the Second Annual "Taste of DeSoto and Business Expo" which is scheduled for Thursday, September 29, 2016 at DeSoto Civic Center, Bluebonnet Room.  - b) Hosted the Third Quarter Membership Luncheon "Methodist Charlton Update" on Thursday, September 15th in the Auditorium at MCMC. The event was very good and Chamber members were recognized with certificates. A representative from Senator Cruz's office was invited to speak, as well.
 - c) The Annual Gala "Blueprint for the Future" is scheduled for Saturday, November 5th at the Hilton Garden Inn.
 - d) Hometown Holiday Parade will be take place Saturday, December 3, 2016.
 - e) A Small Business Workshop "Speed Reading to Success" by Howard Berg will take place October 13th at the Chamber.

 - d) The Soaring Eagle Center relocated and expanded its presence to 107 Executive Way. They provide adults with intellectual and developmental disabilities a place to learn, develop friendships and participate in the community.
