- 1. City Council Liaison update regarding City events, meetings, etc. D. Lockhart Jones
 - a) The City Council had a special business meeting on Thursday, March 16th, to speak about work plan and to determine their goals and mentioned that EDC also has good partnership with the City on the similar goals.
 - b) Had the Boards and Commission Banquet on Thursday March 23rd And members were awarded and recognized for their work ethic.
 - c) On Saturday March 25th they had their Home Owners Association involvement workshop. They got some creative ideas on member participation, HOA grants and residential water conservation from a landscape specialist.
 - d) The upcoming Annual Recycling Event is taking place April 8th for the City residents at 809 W. Spinner Road; from 9:00 a.m. to 12:00 p.m. will have document shredding and maximum of 5 boxes allowed.
 - e) The employee appreciation luncheon is June 22nd City Council will be serving meal for employees from 11:30 to 1:30 p.m. in Bluebonnet Room, to thank them for giving service to their citizens.

 - a) They are getting ready for DeSoto Living Festival on Saturday, April 1st the EDC is a participating sponsor and will have a booth.

- f) President Terhune received an application for a Revolving Loan for business operating a food van and would like a drive thru and carry out business. She recommended that they speak to Mr. Cheatham regarding incubator.
- g) The Job Fair is Wednesday, April 19th 10:00 a.m. to 1:00 p.m. at DC3, organized by City of DeSoto, DeSoto EDC, Chamber with Workforce Solutions.
- h) The Business Advocacy Committee met with Brubeck Investments regarding large apartment complex on Beltline and Westmoreland and they support project.
- i) She spoke to Dr. Cornell of CTC Chiropractic regarding renovations; they had permit issues, but will be opening soon. MomPremier Eye Institute had the Ribbon Cutting on March 21st, with good community support.

Global Prime project has been approved by City Council. Both Mr. Cheatham and Mrs. May attended the Council meeting.

The Brookhollow Shopping Center is in progress and the DEDC CEO is working with owner on the project. They discussed rendering, site renovations, zoning, tenants, and retail name. Project will be designed for small business incubator and coworking spaces. It is projected to have grand opening on July 1, 2017.

NFI is open for business and Mr. Cheatham toured location at same time that upper management was in town. Company is currently at 150 employees, will be hiring 30% PT, have three shifts, and is anticipating full occupancy by August 1, 2017.

Home2 Suites - Mr. Cheatham met with the owner and discussed the addition of meeting space, and the completion of the Hotel expected by end of July 2017.

Solar Turbines has completed expansion, DEDC CEO also toured this location. He mentioned that they are a great Corporate Partner and had discussion about the equipment, market and clients.
